LIMITED LIFETIME WARRANTY

All other MILWAUKEE Personal Lighting Products* (see exceptions below) are warranted to the original purchaser only to be free from defects in material and workmanship. Subject to certain exceptions, MILWAUKEE will repair or replace any part on a personal lighting product which, after examination, is determined by MILWAUKEE to be defective in material or workmanship for the lifetime of such personal lighting products.

Normal Wear: This warranty does not cover repair or replacement when normal use has exhausted the life of a part including, but not limited to clips, straps, charging cables, wall plugs, and rubber gaskets. This warranty does cover the LED in the personal lighting products, subject to the limitations herein

*This warranty does not cover Cordless Battery Packs or Chargers. There are separate and distinct warranties available for these products.

Return of all personal lighting products to a MILWAUKEE factory Service Center location or MILWAUKEE Authorized Service Station, freight prepaid and insured, is required. A copy of the proof of purchase should be included with the return product. The above warranties do not apply to damage that MILWAUKEE determines to be from repairs made or attempted by anyone other than MILWAUKEE authorized personnel, misuse, alterations, abuse, normal wear and tear, lack of maintenance, accidents, or caused by alkaline batteries.
